



2010 CAMP APPLICATION INFORMATION & INSTRUCTIONS

Dear Parent / Guardian;

We are looking forward to an enjoyable 49th camping season in 2010. Starting July 4th 2010 we will be offering seven full weeks of camping.

Our application form has been altered in order to capture the registration information more effectively and to lay the foundation for recording reservation information online. In order to minimize any confusion that could result from these changes, we have prepared detailed instructions on how to complete the application and an explanation of why this information is needed.

GOALS AND POLICIES

At Bates Bar J, our goal is to promote good fellowship, appreciation of outdoor beauty, wildlife and domestic animals and to strengthen high standards in moral character. Young people should develop new skills, make new friends, improve character, and assimilate the beauty of mountains, hills, streams, wildlife and woodland, all the while having good fun.

In order to help us achieve this goal, the directors reserve the right to dismiss any camper whose conduct is considered detrimental to the standards maintained by this ranch. Cause for removal from camp includes, but is not limited to, bullying, and the use of tobacco, drugs or alcoholic beverages. These standards are rigidly upheld. PAYMENT TERMS

- Fees are \$775.00 per week including a handling fee of \$90.00, GST and government room tax.
- If arriving by bus or plane, transportation to and from Calgary is available for \$60.00 per camper. (\$30.00 one way)
- If full payment does not accompany the application, a deposit of **\$275.00** per camper per week must accompany the application. The balance must be paid at the time of check-in by cash, certified cheque, or money order.
- We are not equipped to handle credit or debit cards.
- 5% discount when there are three or more from one family.
- Make certified cheques or money orders payable to:

- In case of withdrawal from camp on a physician's order, a gift certificate will be provided for the equivalent of the unused portion of the camp fee.
- No refund will be made for any other withdrawal/dismissal from camp, arriving late or leaving early.

CANCELLATION POLICY

- There will be no refund for cancellation made after 30 days prior to the first day of camp, unless the cancellation is accompanied by a doctor's note.
- There is a \$90.00 handling fee that is included in the camp fees. In the event of a cancellation, the \$90.00 processing fee is non-refundable.
- All refund requests will be processed no later than September 30

MANDATORY EQUIPMENT

All riders are required to wear an equestrian approved helmet. If the camper has an approved equestrian helmet, please have them bring it, if not, we will supply an authorized helmet. Non-laced riding boots and/or rubber boots with a defined heel are required for riding.

LOST AND FOUND

The Ranch cannot be responsible for lost or damaged clothing or other articles. Unfortunately used clothing cannot be shipped COD, thus every article should be name tagged and we recommend a list of belongings to check off when leaving. If not called for within 30 days of your child leaving the ranch, any unclaimed items will be donated to charity.

CAMP ARRIVAL AND DEPARTURE

Camper registration takes place on Sundays from 2:30 pm through 4:30 pm. Pick-up takes place on Saturdays from 6:00 pm through 8:00 pm. **Do not bring campers before 2:30 P.M. on Sundays. Please pick up after 6:00 P.M. Saturdays.**

2010 CAMP CALENDAR

Please use the calendar to determine the week(s) that are best for you. You will be asked for first and second choices on the application form. The second choice provides an option in the event that there is no space available in the week(s) that you indicate as your first choice.

COMPLETING THE APPLICATION FORM

The Camp Application form is a two page form. This form must be completed for each camper. Required fields are marked with an asterisk (*). If a form is missing any required field it will result in a delay in processing until the necessary information is provided.

CAMPER INFORMATION – All fields with the exception of camper E-Mail address are required.

PARENT / GUARDIAN INFORMATION – Please provide as much contact information as possible. If we need to get in touch with you in a hurry, this information is invaluable. Please place a check mark over the information of the Parent / Guardian that should be contacted first.

CONTACT INFORMATION – In the event that you are not available, please provide alternate contact information. If you plan to be away, these contacts should be provided with a limited power of attorney so that they are able to make decisions on your behalf in the event of a medical emergency.

CAMP WEEK SELECTION – Based on the information in the calendar, indicate your week selection(s). The second choice should be completed as well to ensure a place at camp. Campers who are booked for two or more consecutive weeks are welcome to stay at camp Saturday night at no extra charge.

CODE OF CONDUCT – Please read this section carefully and discuss the meaning and implications with the camper. This section **MUST** be signed by the camper and a Parent / Guardian.

QUESTIONNAIRE – This section helps us address the specific needs of campers.

COMPLETING THE WAIVER AND RELEASE FORM

The Waiver and Release form is part of the camp application. It must be completed for each camper. Please ensure that the form is completed, signed and dated. Campers will not be permitted to participate in any activities if we do not receive this form.

COMPLETING THE MEDICINE ADMINISTRATION FORM

If your child requires medication, please complete the Medication Administration Form and present it to the camp staff on registration day. Do not mail this form to us.

WAIVER AND RELEASE FORM

PLEASE READ

I _____, (camper) hereby acknowledge and agree that in consideration of being permitted to participate in programs or activities organized, operated or sanctioned by Bates Bar J Ranch, herein called "the Ranch":

1. I do hereby release, waive and discharge the Ranch, its officers, directors, independent contractors, employees, volunteers and agents, all recourse, proceedings, claims and causes of action of any kind whatsoever, in respect of all personal injuries or property losses which I may suffer arising out of or connected with, my preparation for, or participation in, the aforesaid programs or activities EXCEPT where and to the extent such personal injuries or property losses arise out of the negligent acts or omissions of the Ranch, its officers, directors, independent contractors, employees, volunteers or agents. This Waiver and Release extends to all claims of every nature or kind whatsoever, foreseen or unforeseen, known or unknown.

2. And, I hereby acknowledge and agree:
 - a) that equestrian activities and programs are very dangerous, exposing campers to many risks and hazards;
 - b) that, as a result of the aforesaid risks and hazards, I, as a camper, may suffer serious personal injury, even death, as well as property loss;
 - c) that some of the aforesaid risks and hazards are foreseeable, but others are not;
 - d) that I nevertheless freely and voluntarily assume all the aforesaid risks and hazards, and that, accordingly, my preparation for, and participation in the aforesaid programs, races and activities shall be entirely at my own risk;
 - e) that the Ranch may use photographs or videos that I appear in for promotional purposes;
 - f) that the Ranch may keep my information on file for a minimum of three years and that my information will be kept confidential and not sold or given to any other organization;
 - g) that I carefully read the WAIVER AND RELEASE agreement, that I fully understand and accept its terms, and that I am freely and voluntarily executing the same;
 - h) that this WAIVER AND RELEASE agreement is binding on myself, my heirs, my executors, administrators, personal representatives and assigns.

3. In the event of any injury or illness, I authorize the Ranch staff or their designate to seek and obtain such emergency or medical services as may be deemed necessary at the time.
